Ọ bụ iwu nke nzuko niile di na DHS enye aka ego dabeere na ida ogbenye ma ọ ụgwọ oké onụ elu maka ndi orja na-izute kpomkwem ego ibiere na rịọ ndi di otu ahụ aka. Ebumnuche maka usoro amuma ndi a bu i ji kowaa etu e nwere ike isi agbaso aririọ maka enyemaka ego, ihe ndi a chorọ maka ndi tozuru etozu na usoro a na-agbaso maka iriọ aririọ maka enyemaka.

Otu DHS ga-ebiputa n'akwukwo ọgwụ nke obodo ha, ọdidi nke Enyemaka maka ego n'afọ ọ bula ma ziputakwa ozi iji mee ka a mata maka ọdidi ya n'ebe dacha mma nakwa ebe a na-enye ndi mmadu akwukwo maka akwumugwo. E nwere ike inyere ndiorja aka, bu ndi nke mmefu na mkpata akw nke ha di n'aka ndi na-anako ya. Ebe nke a nwekwara ike ibu maka ndi nke e kpebirila ikpe maka ha.

DHS nwekwara ikike nke ya ikpebi ma onye orja o nwere ike ikwunwu ugwo ọgwugwu e nyere ya. Ndi orja niile a kpotara maka ọgwugwo mberede ka a ga-enye ọgwugwo na-agbanyeghi ma ha o nwere ike ikwunwu ugwo. Gbasatara oru daputara mberede ma o bu a kwadoghi akwado, a ga-emezucha usoro akwumugwo, usoro nnata ego, ma nyochakwaa ya etu o kwesiri mana nke a agaghi egbochi onye orja inata ọgwugwo nke kwesiri ya.

ATUMATUNTORU

Dika ha na-arụ oru ahuike ha etu niile o kwesiri, na-ekwuchitekwaru ndi nke na-enweghi uzọ ha si akwu ugwo maka ọgwugwo di mkpa e nyere ha na-eleghi anya n'azu, ulogwu ndi DHS na-agbasi mbọ ike ihu na onodu mkpata akw nke ndi mmadu na-achọ ahuike egbochighi ha icho nakwa inata nleta anya.

Ebe e wepuru maka usoro amuma enyemaka gunyere ndi a:

1. Oru nke ndi ahuike ruru nke na-enweghi mmetuta n’ebe ulogwu ndi DHS di (omumaatu, ngwaoru nke ahuike, oru nlekwa e nyere n’ulo onye oria)
2. Onyoria nke nshoransi ya ma o bu amuma ogwugwo ya na-agunyeghi uloru nke nshoransi (iji maa atu, HMO, PPO, ma o bu ego iti aka n’obi maka ndi oru), ha bu ndi na-etozughi amuma enyemaka ego.
 - a. N’uzo doru anya, Amuma Enyemaka Ego anoghi maka iru oru n’ebe ndi nke uloru nshoransi nke ha juru inyere aka; na-agbanyeghikwa, e nwere ike ilebanye anya na nsogbu nke o bu na n’onwe ya site n’itule nsogbu ahuike na mputura ya nwere ike iweta.
3. Ego ndi a na-akwughi akwu nke sitere n’ihe ndi na-agbasaghi oru ahuike;
4. Ihe ndi onyoria ji eleta onwe ya anya
5. Ugwo nri na nke obibi
6. ***Ego onye na-enye ogwu na-ana nke metutara ubochi a ruru oru esoghi n’amuma Enyemaka Ego nke DHS. Onyoria nke nwere ike igbaso enyemaka ego maka ego metutara ugwo a na-akwu ga-akpoturu onye ahụ na-enye ogwu n’onwe ya.***

Onyoria etozughi maka amuma enyemaka ego n’ihi ihe ndi a:

1. Iju iweta akwukwo a choroma o bu iweta ozi ezughi ezu.
2. Inwe nshoransi site na HMO, PPO, ego iti aka n’obi maka oru, Medicaid, ma o bu amuma nshoransi ozoma nke juru nnabata maka ugwo ulogwu nke usoro atumatu ndi nshoransi.
3. Akwughi ugwo ndi nke a choro maka Amuma Enyemaka Ego.
4. Odida na-ruo ubochi na ugwo ndokwa ndi DHS.
5. Iju imata ihe a choroma n’aka gi n’oge ya maka usoro akwumugwo nke DHS.
6. Iju ime nhazi maka ugwo e kwesiri ikwu DHS n’oge gara aga (nke gunyere ndioria ndi ahụ e zigara nke na-abughi ndi otu ndi na-anakoma ego e ji n’ugwo).
7. Iju ka e mee nyocha maka enyemaka ego ndi ozoma tupu a hanye aririo n’aka ndi otu Amuma na-akwu ugwo.
8. Iju inye ozi di mkpa gbasara ihe nke no n’iwu maka ndi ala ozoma na-abia n’Amerika na-achoma ogwugwo oria mberede.

Ndioria na-etozughi maka amuma a ka a ga-achoma ka ha kwuo ego ole o bu e nwere ike igwa ya kwuo. O ga-abukwa oru arughi nke oma ma o buru na a kwughi ego o bu e kwesiri ikwu n’oge a ga-ekwekorita maka ikwuzu ya.

Ndioria mere ka a mata na e webeghi ha n’oru nakwa na ha enweghi nshoransi ha no na ya ga-eweta Akwukwo Aririo maka enyemaka ego, beeluso ma ha tozuru etozu n’etu niile e si amata ndi e chere na ha ruru eru inweta Enyemaka ego. O buru na onyoria tozuru maka nlekoma nke otu COBRA, onyoria nwere ike ikwu nshoransi COBRA ka ndi Kansul/ ndi nlekoma ga-elebara anya, ebe a ga-edede akwukwo nkwardo nye Ndiji Ochichi. Ndi nke nwere ike izutanwu nshoransi ahuike ka a ga-agba ume ime etu ahụ, dika uzoma e si enye aka ibanye n’oru ahuike nakwa ihe niile gbasatara ahuike nke onye.

Ego ole o na-ewe ga-agbado ukwu n’ihe di n’agbata 200-500% nke ego a na-enweta ma burukwa nke gogoment etiti na-enye ntuziaka maka ibelata agbu na-ebiputa n’afoma o bu e bu n’Akwukwo-Ndeputa nke Gogoment Etiti. Usoro nhazi ahụ na-amalite n’otu onwa nke na-esochi onwa mbu e jiri biputa akwukwo ahụ.

Ebe e nweghị ihe njinaaka e ji akwado ntozu maka enyemaka ego, otu DHS nwere ikike mnwere onwe i si n’aka otu ozọ nweta ozi nke na-akọwa maka mkpata akụ maka inyere onye tozuru etozu ma nyekwa aka wetuo ego ole o kwesiri ikwu. Ozugbo e kpebiri nke a, n’ihi etu onodu nwere ike idi, nani enyemaka ego e nwere ike inye bu 100%. 1. E nwere ndi o bu oru ha ihu maka Aririo Enyemaka Ego. Ndi oru a nwere ike ibu ndi ndumodu n’ihe Gbasatara Ego (Financial Counselors), Ndi na-ahu maka mnweta Ego ndiorjia (Patient Financial Receivable Coordinators, ndi nnochite anya ndi na-azuru ahia (Customer Service Representatives), Wee diri gawazie.
2. A ga-agba mbọ niile e nwere ike ya ihu na a kpara maka ihe niile gbasara ego onu ogwugwo orja tupu ubochi a ruru oru. Ebe o kwere omume, onye oru ga-akpo site n’ekwentị ma o bu zute onyeorjia nke rioro maka Enyemaka Ego iji mata ma o tozukwara etozu inyere aka.

6. Ozugbo a nabatara inyere onyeorjia aka, , Financial Assistance coverage ga-amalitezi site n'onwa ahụ e kpebiri wee ruo n'afọ atọ, afọ isii n'odjinihu. E nweghikwa njedebe n'ogo e tozuru etozu maka enyemaka. Oge ọ bụla e kpebiri ka a ga-agbaso site n'iso ya n'usoro n'usoro. Ọ bụrụ na e nwetara mgbakwunye na nlekwa ahụike nke gafere oge a kwadoro, onyeorjia ga-edeghari akwukwọ aririọ maka nhazighari. Na mgbakwunye, mgbanwe n'ebe mnweta ego onyeorjia nọ, ngwongwo ya, mmefu ego ma ọ bụ onodu ezinụlọ ka a tūrụ anya na a ga-akowara ngalaba Atumatụ Enyemaka Ego. Nnakota ego ndi ọzọ puru iche (Extraordinary Collections Action), dika a kowara ya na ndida, ka a ga-akwusi ozigbo a nabatara onyeorjia maka enyemaka ego, ebe a ga-akwughachi onyeorjia ego ya ndi foro afọ.

Ihe isiike nke ego

Ego o buka e mefuru nke na-enweghi nshoransi, maka ogwugwo orja n’aka ndi DHS o buka ka a ga-eji wee mara ma onyeorjia ahụ o nwere ntozu maka amuma enyemaka ego. Usoro ndi a ka e weputara iche, ma burukwa ihe mgbakwunyere nke e ji ekpebi maka enyemaka Ego, o bukwazi ya ka e ji Financial Hardship wee mara. A ga-enye onyeorjia o buka rjoro maka enyemaka ego ihe a kporo Financial Hardship.

Enyemaka Ego Financial Hardship dikwa maka ndiorjia na-etozughi maka Enyemaka Ego nke nokwa nokpuru ngalaba ogo di ala, mana o bu maka onye:

- 1) Ugwo ulogwu DHS e mefuru n’isi ya gafere 25% nke ego ezinulo ya na-enweta n’otu afo., ma burukwa nke na-enwe ihe isiike nke ego maka ogwugwo orja (Medical Financial Hardship) nakwa
- 2) Onye nke tozuru oke maka ogo enyemaka a.

Maka onyeorjia tozuru maka nke a kporo Ego nleta e weturu ala (Reduced Cost Care) nke no nokpuru nke a kporo primary Financial Assistance, nakwazi Financial Hardship Assistance criteria. DHS ga-anabata mbutu nonwego nke ga-adi onyeorjia ahụ obi mma maka ogwugwo ndi di mkpa maka ahike ya nke otu ezinulo, ihe karij onwa iri na abuo ma gafekwaa 25% nke ego otu ezinulo na-enweta maka otu afo.
