# Quality of Care



**Andrew Rosenstein, MD, chief of the Department of Gastroenterology at UM St. Joseph Medical Center,** is crystal clear when talking about his responsibility as chief of the Department of Gastroenterology at UM St. Joseph Medical Center. "I'm here to see that the patients who come to St. Joe's get the absolute finest care that we can provide. That means sometimes making hard decisions but if it's in the best interests of our patients, I have never hesitated," he says emphatically.

That dedication to excellence came early to Dr. Rosenstein. The son of a pediatrician and grandson of world-renowned psychiatrist Albert Kurland, MD, the bar was set high. However, Dr. Rosenstein never felt pressured by anyone in his family to pursue a career in medicine and for this, he is grateful. "I planned to be a writer or a lawyer," Dr. Rosenstein says with a laugh, but by his sophomore year at the University of Rochester, he couldn't resist the lure of the sciences. "I am so grateful I had the opportunity to pursue a liberal arts education. The intellectual dexterity that comes with a breadth of education has made me a better physician. Science is only one part of the equation. You may be trained to ask all the right clinical questions, but more often the answers come from insight and empathy to the patients' non-verbal cues."

A third-generation graduate of the University of Maryland School of Medicine, Dr. Rosenstein completed his residency and fellowship there, planning his career in gastroenterology (GI). "GI combines my love for clinical intervention and the challenge in providing complex care when patients present with many concurrent symptoms. My brilliant mentor from medical school, Steve James, told me a physician is defined by his difficult cases. He created a template for practicing medicine that I follow to this day."

Dr. Rosenstein is equally enthusiastic when talking about his family life. "I came to fatherhood a bit late in life and my wife Michele and I are dazzled daily by our five-year old son, Aiden. Any free time that I have, I want to spend with them." When Dr. Rosenstein supports the Foundation by making significant gifts, he sees his son. "He is the future. I want Aiden to always have access to a hospital with a culturally caring environment and that takes philanthropy. I've found that culture at St. Joe's. It's the reason why I decided 19 years ago to practice here and continues to be a major reason why I stay."

## *Michele's Story*



*When Dr. Michael Schultz, the medical director of the Breast Center at St. Joe's, told me that I had breast cancer in 2015, I saw only one image in my mind: my two-year-old son, Aiden. He is our 'miracle child' and not*

*being here to see him grow up is simply not an option. I immediately wanted to have a bilateral mastectomy and reconstruction. Dr. Schultz understood my laser-light focus, but insisted we would handle my diagnosis "the right way," not "the emotional way." Only after the Cancer Institute's multidisciplinary committee agreed that this surgery was the correct course, did we move forward.*

*I am a nurse practitioner so I am very familiar with the medical world, but when the diagnosis happens to you, there is no preparation to handle the multitude of feelings that wash over you. It was such a blessing to have Dr. Schultz understand and empathize completely with what I was feeling. He ensured that I received results quickly, was available any time of the day or night to speak with me, and, best of all, reassured Andrew and me that my type of cancer was highly treatable and I would be just fine.*

*I went into nursing because of a family friend who served as a role model. Her true concern for her patients was such a lovely thing to observe and I vowed to take care of people with the same loving service. Being on the receiving end of this type of care has taught me so much more about the power of kindness and compassion. It has been a gift that I try to bestow on Aiden each and every day.*

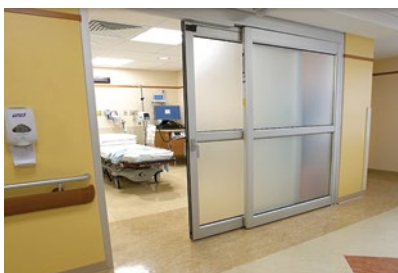
# UM St. Joseph dedicates *renovated and expanded space* on our Mother Baby Unit



◀ After waiting nine long months, it is time for expectant moms to bring their little one (or little ones!) into the world. Their first stop is **The Faith Marguerite Kelly Welcome Center**, named in memory of the granddaughter of The Honorable Francis X. Kelly, Jr. and Mrs. Janet Kelly. Improvements include a registrar and greeter who meet every family, helping calm nerves and getting expectant moms exactly where they need to be.



▲ **Five postpartum rooms** have been renovated to include private bathrooms, flat screen TVs, night lights, an oversized rocking reclining chair, artwork to disguise medical equipment and a sleep sofa.



◀ The renovated and expanded **Triage Unit** has a new **exam room**, enhanced **nursing stations** and **five new patient bays** with sliding doors that allow for complete privacy and help prevent the spread of germs.

Now, the Cooks can see one of the results of their longstanding generosity. The hybrid OR, which they helped fund, will open in February 2018. This state-of-the-art cardiac surgical suite is outfitted to perform minimally invasive procedures on high-risk patients who are not optimal

candidates for open-heart surgery. If a complication arises, however, the hybrid OR can quickly transition into an open-heart operating room. John says succinctly but with a smile, “I hope we don’t have to use it but I’m sure glad it’s there.”

Frank Morris, MD, John’s cardiologist, says, “Fortunately, John’s health is such that I don’t need to see him often but when I do, I always enjoy our visits. Aside from his great sense of humor, John and Norma are a reminder to me of the folks who really love St. Joe’s and the spirit of generosity that has always sustained us. It’s what allows us to thrive and be there for everyone in our community.”

Receiving her diagnosis quickly gave breast cancer patient Rosemary Mukhopodhyay peace of mind



**Stoneleigh resident Rosemary Mukhopodhyay** did not have time for cancer. In November 2015, the grandmother of two little girls, Sloan and Anika, was busy helping to care for her granddaughters while her son and daughter-in-law worked full time. Meeting the school bus, hosting playdates and traveling with her husband, Chirantan, happily occupied most of Rosemary's time. And, Christmas was just around the corner.

A routine visit with her internist, Vincent DiPietro, MD, however, turned her world upside down. When he felt a lump in her breast, he immediately arranged to have her see the radiologist who had done her prior mammograms. Still reeling, Rosemary was soon told by the radiologist that she most likely did have cancer, but it would be a week before she could be scheduled for a definitive biopsy.

"That is exactly 168 hours to wait and worry," says Rosemary. "I called Dr. DiPietro in tears

and he immediately told me that a week's wait was unacceptable," "I'm calling Michael Schultz, the medical director of St. Joe's Breast Center right now and you will know your diagnosis in 24 hours." Rosemary was able to take advantage of Dr. Schultz's compassionate initiative, *No More Sleepless Nights*™, that ensures a woman has a biopsy, receives the news and has a plan moving forward within 24 hours. For this innovative program, Dr. Schultz received the 2011 Inspire Award from the Tigerlily Foundation, a national organization that supports women under the age of 40 with breast cancer.

"When Dr. Schultz called he didn't mince words. He said I had breast cancer. But I will never forget his next three words: 'treatable, curable, livable.' That was sweet music to my ears. From then on, I knew I was going to be safe in Dr. Schultz's hands." Over the winter and spring of 2016, Rosemary underwent chemotherapy, followed

by a bilateral mastectomy and breast reconstruction. She is now cancer free and busier than ever with her family.

"There is so much more to the breast cancer experience than the clinical care," she says. "I feel so fortunate that Chirantan and I can make an annual gift to support the Geraldine G. Schultz Fund for Breast Cancer Survivors. This fund is going to support all the psycho-social needs that patients have, and we have many after hearing, 'You have cancer.' It so beautifully embodies the loving care that I received from Dr. Schultz and everyone on his team. I'm thrilled that his model of care will reach so many others."

# Finding Sanctuary



2009 was an unspeakably painful year for Homeland resident Joanne Mazzie. In the span of nine months, she lost first her brother, John, and then her mother, Anna. Joanne was so overwhelmed with grief at the loss of these beloved family members that she was encouraged to seek counseling or join grief support groups. Instead, she found

solace not with people, but in a place: The St. Francis of Assisi Chapel, dedicated in loving memory of Carmen J. and Theresa R. Deyesu, at University of Maryland St. Joseph Medical Center. This became the healing center that had such a profound influence on her journey back to spiritual wellness.

“I knew that St. Joe’s was a very special place when my brother became so sick. John had acquired bacterial meningitis and was treated for several weeks in the hospital’s intensive care unit. Because he would not recover from his condition, difficult decisions had to be made. It was the compassionate and unwavering comfort from the nurses, doctors and Spiritual Care Department that convinced us to do what was best for John and certainly what he would have wanted,” says Joanne.

When Joanne’s mother, Anna, passed away from cancer, she was feeling bereft and angry, beginning to question her faith. But Joanne was drawn time and again to the chapel on campus. It was there that she would just sit quietly and reflect on her memories of her family and God’s plan for her. Sometimes, Joanne would be alone in the chapel, enjoying the quiet peacefulness, but always feeling a strong, comforting presence surrounding her; other times she would celebrate Mass with the large Saturday evening congregation, basking in their shared love for the Holy Spirit. “My faith and my capacity for joy returned.”

Joanne’s experience in the St. Francis of Assisi Chapel was so meaningful to her that she decided to make a planned gift to support the spiritual care programs at UM St. Joseph. “I kept getting advice from well-meaning friends about how I needed to connect with someone to recover from my sadness. The answer was not a person but a place of worship, right at St. Joe’s,” she concludes with a smile. “I want to make sure that others in pain will always have this wonderful hospital chapel to help them become whole again.”

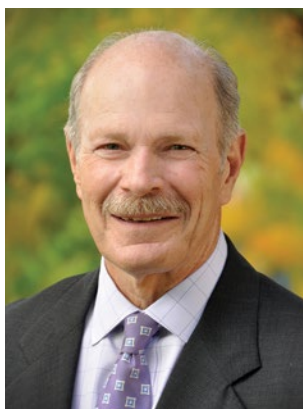

# LETTER FROM RAYMOND DAUE, CHAIR OF THE FOUNDATION BOARD OF DIRECTORS

Dear Friends,

This has been a spectacular fiscal year for the UM St. Joseph Medical Center Foundation. I am grateful to our many friends and supporters who made this a record-breaking year! As always, I am thankful for such a tremendous Foundation Board who work so tirelessly on behalf of St. Joe's. This year, we welcomed eight new board members, each one bringing unique talents and experience that will advance our mission to seek the philanthropic support of our community.

In reviewing our Philanthropy Dashboard on the following page, I was struck by several statistics. While it is wonderful to report that so many friends contributed well over \$11 million for the hospital, I think it is equally noteworthy how those funds were designated. Nearly half (45%) was designated to Spiritual Care and Care for the Underserved, while 43% was earmarked for Surgical Excellence, a capital initiative to renovate our operating rooms. I believe this demonstrates that our donors are equally invested in clinical outcomes, supporting our mission as a faith-based hospital and helping those less fortunate. Your focus perfectly matches that of the medical center.

Second, in fiscal year 2017, St. Joe's was the recipient of an exceptionally generous planned gift, the largest gift the hospital has ever received. This bequest underscores the importance of planned giving. An intent made in 1997, designated to help the underserved, is resulting in our ability to significantly help those in need today, especially important given the current challenges in finding affordable health care.

As always, I want to extend my gratitude to our wonderful supporters, including 363 new donors who contributed \$1.46 million. This represents an extraordinary commitment to St. Joe's, promising a future that will make our community stronger and healthier—a win for all of us in the coming years. Thank you.

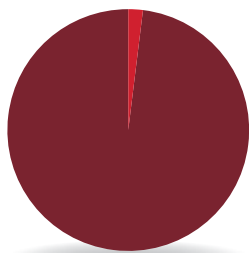

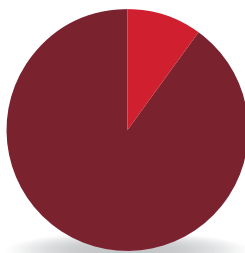

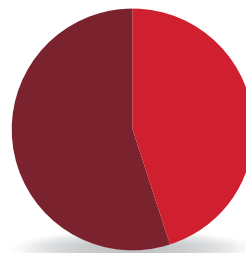

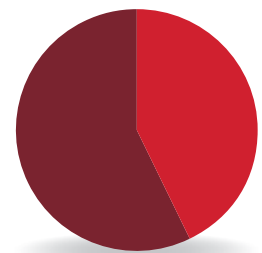
